Bench Policy 1.2.1 establishes a standing committee system to assist the Bench and the Presiding Justice of the Peace in accomplishing the governance and administrative functions of the Maricopa County Justice Court.

The policy provides that membership in all committees is concurrent with the term of the appointing presider and in accordance with Bench policy 1.2.1. Membership in the Professional Standards and Policy Committee shall consist of the Associate Presiding Justice of Peace as Chairperson, chairpersons of other standing bench committees, with a minimum of five (5) Justices of the Peace appointed by the Presiding Justice of the Peace and approved by a simple majority vote of the bench. A designee of the Presiding Judge of the Superior Court shall serve as a non-voting member. In Accordance with Bench Policy 1.2.1, section 2.2, the Presiding Judge is responsible for appointing members to the Professional Standards and Policy Committee (PSP) and may make changes as necessary. Therefore, after due consideration,

**IT IS ORDERED** that Sammi Levine and Jackie Paredes are appointed to the Professional Standards and Policy (PSP) Committee as non-voting manager members, and Hon. Ashley Fitzwilliams is appointed as a Judge member.

**IT IS FURTHER ORDERED** that ex-officio member of the Committee Hon. Anna Huberman is removed and replaced by Hon. Leonore Driggs as an ex-officio member of the Professional Standards and Policy (PSP) Committee.

**IT IS FURTHER ORDERED**, the appointment of Hon. Jennifer Jermaine as Chairman of the Professional Standards and Policy (PSP) Committee for a term ending concurrent with the term of the presider.

**IT IS FURTHER ORDERED**, the individuals listed in Appendix A are appointed to the Professional Standard Policy (PSP) Committee.
