INFORMATION REGARDING THE ACCOUNTING LEDGER IN EVICTION ACTION CASES

As stated in the Rules of Procedure for Eviction Actions, Rule 5d(4)

"If the action is based on non-payment of rent, a copy of the accounting of charges and payments for the preceding six months must be served with the complaint."

To assist you with this requirement, below is an example of an accounting ledger.
